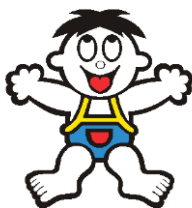

POLL RESULTS OF 2016 ANNUAL GENERAL MEETING AND PAYMENT OF FINAL DIVIDEND

At the annual general meeting (the “AGM”) of Want Want China Holdings Limited (the “Company”) held on 6 May 2016, a poll was demanded by the chairman of the AGM for voting on all proposed resolutions (the “Proposed Resolutions”) as set out in the notice of the AGM dated 1 April 2016 (the “Notice”).

As more than 50% of the votes were cast in favour of each of the above Proposed Resolutions, all Proposed Resolutions were duly passed as ordinary resolutions of the Company.

Notes:

- (1) The Company's Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM.
- (2) As at the date of the AGM, the number of issued shares of the Company was 12,737,299,135 shares, which was the total number of shares entitling shareholders to attend and vote on all Proposed Resolutions at the AGM.
- (3) There were no restrictions on any shareholders to cast votes on any of the Proposed Resolutions at the AGM.
- (4) No parties have stated their intention in the circular dated 1 April 2016 containing the Notice to vote against or abstain from voting on any Proposed Resolutions at the AGM.

PAYMENT OF FINAL DIVIDEND

In relation to the ordinary resolution No. 2 above, the final dividend will be paid on Friday, 27 May 2016 to shareholders whose names appear on the register of members of the Company as at Friday, 13 May 2016. In order to qualify for the entitlement to the final dividend, all transfers accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited at

Shops 1712-1716, 17th floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 p.m. on Wednesday, 11 May 2016, for the purpose of effecting the share transfers. The register of members of the Company will be closed from Thursday, 12 May 2016 to Friday, 13 May 2016 (both dates inclusive). Shareholders registered under the principal register of members in Cayman Islands will automatically receive their dividends in United States dollars ("US\$") while shareholders registered under the Hong Kong branch register of members will automatically receive their dividends in Hong Kong dollars ("HK\$"). The HK\$ equivalent of the final dividend is HK\$0.097 per share which is based on today's exchange rate of US\$ against HK\$ at US\$1.00 to HK\$7.757.
